	<p>previous provider) to plan transition prior to enrolment to Longley Park sixth form.</p> <p>Consultation process is in place, for applications of learners with EHCP's to outline learners' requirements or additional learning and medical needs to ensure we can meet the need of the learner.</p> <p>We offer visits and meetings to arrange transition plans for learners with EHCP's and special educational needs and disabilities prior to applying to the college. We offer advice on course options and progression routes.</p> <p>We have a next steps event to allow learners to experience the college for a day, by meeting teachers, tutors and support staff as well as attend lessons.</p> <p>Learners are supported during enrolment and induction to ensure that the learners' transition arrangements are being met. Learners meet with additional learning support coordinators on the day of enrolment to discuss and plan for adaptations and strategies for lessons, according to their needs. Plans are put in place to ensure learners can access learning, opportunities, services and support.</p> <p>Teachers and support staff are informed of adaptations and strategies. Quality first teaching is implemented to support all students and allow learning to be accessible for all. Graduated approach is planned into lessons, to ensure that support plans are implemented and reviewed regularly.</p>
